### **Trainers' Biography**

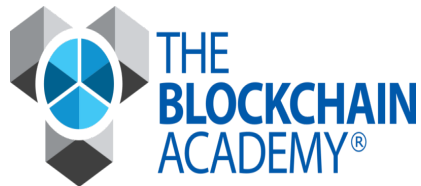
